Lee Solter (LS) called meeting to order at 10:37am

1. Welcome and Agenda Review (LS)

LS welcomed attendees and briefly showed the Meeting Agenda. She then introduced Karl Maramorosch, who gave a captivating presentation titled "The

three Gs: personal reminiscences of invertebrate cell culture pioneers: Goldschmidt, Gao and Grace". After the presentation Dr. Maramorosch was recognized with a standing ovation.

2. In Memoriam (LS)

Retired SIP members. Names of retiring members were read and recognized with applause. Members were: Mark Goettel, Just Vlak, Jeff Lord, and Nguya Maniania.

Deceased SIP members. LS requested a minute of silence to honor and remember the SIP members that passed away in the last year. Members were: Nancy Beckage, David Cooper, Carlo Ignoffo, John Kramer, Albert Pye, Albert Sparks, Flavio Moscardi, Jaroslav Weiser and Constantin Vago.

3. Minutes of the 2011 Business Meeting (LS)

Minutes were approved and are posted on the SIP website

4. President's report (LS)

From the standpoint of finances, the two past meetings (Trabzon 2010 and Halifax 2011) were profitable (more in Treasurer's report). Finances also successful due to sponsorship; LS pointed out a banner with all the sponsors contributing to the SIP meeting in Buenos Aires asked for applause to recognize them. Martignoni and Lomer awards cannot be maintained only with the generated interest due to low rates, the silent auction made about \$1,200 this year which will be used to fund both awards. Last year dates for the SIP fiscal year were changed to May 1st-April 30th to match the dates used by the US revenue service (IRS) and to make tax reporting easier.

Continuing a multi-year trend, membership was lower in the past year. LS stressed the need to work on advertising and convincing new potential members. Despite potential financial issues related to reduced membership, profitable meetings and sponsor's contributions have resulted in a balance representing more than two-times the operating costs of the Society. All SIP Divisions are financially healthy.

Eric Haas-Stapleton has been the new Newsletter Editor and LS shared his message inviting for submission of files and input. He also suggested the help of an Assistant Editor from the membership.

A new meeting website has been developed and used this year for the first time. The website is owned by SIP; Cecilia Schmidt (CS) can change and adapt each year so there is no expense for website design for future SIP meetings. LS thanked and recognized the presence of Susan Bjornson (SB) as organizer of the Halifax 2011 meeting with applause.

New Council Officers elected this year: Peter Krell (Vice President), Patricia Stock (Secretary), and Ed Lewis and Surendra Dara (Trustees). Kelli Hoover generously agreed to remain as Treasurer for a second 2-year term.

Student workshop was announced to incentivise assistance. Announcements were made for picking up and paying auction items and signing up for buses to the banquet. No questions from audience. LS then introduced Kelli Hoover (KH).

5. Treasurer's report (KH)

SIP meeting last year in Halifax did very well (about \$26,000 benefit) that together with the income and expenses resulted in more than \$31,000 in net benefit for the General Fund. Also participation of sponsors has been very important, contributing about \$21,000 this year. The meeting in Trabzon also resulted in a net benefit to the Society. Current balance for the Society is \$203, 424.19, which represents more than two times the operating expenses for the Society. There was not enough interest generated from the Martignoni and Lomer Funds to support the respective awards, but funds raised from the auctions as well as funds collected for the portraits by Surendra Dara have help obtain enough funds to maintain the awards.

6. Auditor's report (KH)

David Shapiro Ilan and Steven Arthurs were the auditors and concluded everything looked fine with the Society's finances. No questions from audience.

7. History Committee - Archiving issues (ED)

LS introduced Elizabeth Davidson (ED) as Chair of the History Committee, which was charged with reporting on the archiving situation. Currently there is no room to store the old Society's files. Wayne Brooks has archived materials form SIP's founding to the present at North Carolina State University, including newsletters, correspondence, original constitution, meeting slides and photos. Archiving nowadays is done digitally and the Committee has been investigating possibilities to digitalize and store the Society's files.

University of California at Irvine has a large collection of materials from Edward Steinhaus, but cannot take SIP materials.

The Center for Biological Sciences Archives at the University of Maryland at Baltimore County (UMBC) and Iowa State University (ISU) have offered to archive SIP's materials. They have experience doing this for other scientific societies. If Council approves, the most important materials (newsletters, meeting programs, membership lists...) will be cataloged and sent to UMBC and ISU for archiving. ED asked members for photos, letters and other materials that may be valuable to contact the Committee. The Committee is looking especially for photos of the first SIP meeting. Drauzio and Arlene Rangel have digitized all the newsletters up to 1999 (when they started to be delivered in digital form through the website).

ED also shared some news from the last living SIP Founder, Dr. Carl Sindermann. He retired from the US Fisheries Service in 1990 and published 2 books on Marine Pollution after retirement. He recently submitted a book titled "The scientific research director: and essential figure" and is currently writing another book. He lives in Maryland with his wife.

8. Meeting reports (LL)

LS introduced Larry Lacey as Chair of the Meetings Committee. He introduced Susan Bjornson (SB) as organizer of the 2011 meeting in Halifax.

SB presented information from the 2011 meeting. There were 315 assisting, 164 regular members, 36 student members, 63 non-members, 36 student non-members, 9 companions, and 7 symposium speakers from the OECD symposium (from a total of 18 speakers). These attendees came from 28 different countries. There were 227 regular and 77 student presentations. SB shared pictures from the social program as well as logos for sponsors and thanked the Organizing Committee and Council members for their assistance. The meeting had a benefit of about \$26,000 and the OECD symposium had a \$937 benefit that will go to the Division of Diseases of Beneficial Invertebrates.

LL introduced then Victor Romanowski (VR) from the Organizing Committee for the 2012 meeting in Buenos Aires. There were 310 registrants, 339 scientific presentations totalling 989 authors and including 169 oral (116 regular + 27 student), 170 posters (134 regular + 36 student), and 53 symposia and workshop talks. VR commented on 34 pre-registered for the 5K and 27 runners showing up. Also mentioned problems related to late registrants due to currency exchange issues and suggested encouraging early registration for future meetings to help organizers booking rooms and entertainment.

LL introduced Nina Jenkins (NJ) as organizer of the 2013 SIP meeting to take place from 11th-15th August in Pittsburgh (Pennsylvania, USA). The Organizing Committee also includes KH, co-Chair of the Local Arrangements Committee

and Matt Thomas, Chair of the Scientific Program Committee. The meeting will take place at the Sheraton Hotel at Station Square, with many areas for dinning and socializing around. The BBQ will be on a boat reserved for SIP that will include open bar and disco music. There will be a meeting of NEMASYM (Nematode-Bacterium Symbioses) Research Coordination Network. This group will provide funding for speakers and students who will give any type of presentation (oral or poster) under the theme of the network. Organizers encourage sharing rooms to reduce costs, there are double, triple and quadruple rooms. There will be a feature at the meeting website to facilitate room sharing. For the excursion there will be two options: 1) Andy Warhol museum or 2) Carnegie Natural History Museum (including a private visit to the insect collection limited to 2 groups of 15 persons). The 5K race will be along the river with finish at Station Square (meeting venue).

LL introduced Johannes Jehle (JJ) as organizer of the 2014 meeting to take place from 3-8 of August in Mainz (Germany). JJ presented facts about Mainz history (Roman foundation >2,000-year old, hometown of Gutenberg...) as well as its localization (24 km from international airport of Frankfurt). The excursion will consist of a boat trip on the Rhine River (UNESCO World Heritage Site). Weather will be 20-30°C during the day, cooler at night. There will be pre- and post- meeting tours available to attendees. Tom Hankeln will be Co-chair, Elke Genersch, Chair of the Scientific Committee, Dietrich Stephan, Treasurer, and Regina Kleespies Secretary for the Organizing Committee.

LL stated the committee is looking for potential venues for the 2015 (North America) and 2016 (rest of the world) meetings. There were no questions from the audience.
